### **IMPORTANT NOTES TO EXHIBITORS**

**ELIGIBILITY TO ENTER:** The TDX test is for dogs that have earned the TD or TDU title. A dog may continue to participate in this test after it has earned the TDX title. However, the tracking test secretary will give priority to entries for dogs that do not hold a TDX title.

**USE THE OFFICIAL AMERICAN KENNEL CLUB ENTRY FORM** and write "TDX" in the Obedience Trial Class space. Faxed, telephoned, unsigned, conditional, or incomplete entries cannot be accepted. Entries not on an official AKC Entry form and photocopies of forms without the agreement and Rules on the reverse side of the official AKC entry form are not accepted.

**DRAW FOR ENTRIES:** If entries received exceed the test limit of 6 dogs, a public drawing will be held Wednesday, March 15, 2023, 6:00 p.m. at Blue Springs 'n Katydid Dog Training Center, 2980 W. Oxford Ave. Englewood, CO 80110. Preference for the first 2 tracks drawn will be given to DFTA test workers who submit a DFTA issued worker certification with their entry form. Visit the DFTA website for details of the test worker preference process. An attempt to notify entrants will be made by the secretary within 48 hours of the draw. Long distance phone calls from exhibitors to the Trial Secretary will be returned collect.

**ENTRY FEE:** \$140.00 (in US Dollars) (This includes the 50 cent AKC recording fee and the \$3.00 AKC Event Service Fee.) The entry fee for Junior Handlers is Zero. A junior must have an AKC Junior Handler number and be less than 18 years of age on the day of the event. Make all checks and money orders **payable to DFTA** and mail with entry to **Lynn Kammerer, 1 Glenridge Drive, Littleton, CO 80123**. Entries sent by OVERNIGHT DELIVERY must be marked "no signature required" and must be sent through the US Post Office. Entry fee checks for alternates who do not participate will be shredded by the Test secretary.

**ENTRY FEE WILL NOT BE REFUNDED** in the event of errors or cancellation of entries after the published closing date, except as required by the AKC regulations in Chapter 1, Section 15 and 17 and Chapter 6, Section 6. In the event that a dog is absent, disqualified, excused by judges or barred from competition by the test committee, entry fees will not be refunded. If, because of storms or other acts beyond the control of the management, it is impossible to open or complete this event, no refund of entry fees will be made.

**CANCELLATION OF ENTRIES** before the stated closing date must be made in writing or by e-mail to the Test Secretary, and must be received by the secretary prior to the stated closing time.

**RISK:** The owner or agent entering a dog in a Tracking Test does so at his/her own risk and agrees to abide by all of the Rules and Regulations of the American Kennel Club. The Denver Foothills Tracking Association assumes no responsibility for any personal injury or death of any person, theft of personal property, theft, injury, or death of any animal or loss of or damage to any property while at this test or on the test site, or in transit to or from the site.

**NOTE: By making an entry for any of the events listed in this premium list, the exhibitor agrees to hold harmless; the club, the judges, the event committee, the superintendent/event secretary, venue and any other exhibitor for any transmission of any disease including but not limited to the COVID-19 virus. Public health guidelines and protocols in effect at the time of the event will be followed.**

### **IMPORTANT NOTICES REGARDING OUR TEST SITE:**

Exhibitors may not practice at the test site within three days of the test. Exhibitors and spectators are not permitted to park along the park roads. This is a park rule! Designated drivers will take exhibitors and spectators to track drop-off points or viewing points. Dogs owned or under the control of any persons associated with the Tracking Test must be ON LEAD at all times. This is an AKC rule as well as a Park rule! Training at Chatfield requires a Park issued permit that restricts training to specific fields. DFTA holds a training permit for its members and people training for DFTA tests. Visit the DFTA website for details of the restrictions. A \$10 Park Entry Fee, separate from the Test Entry Fee, is required to enter Chatfield State Park. The exhibitor is responsible for paying this fee. Chatfield State Park is a heavily used, public park, located along the foothills of the mountains. Exhibitors can expect to encounter horses, bicycles and people on established paths through the tracking fields. Wildlife such as deer, elk, coyotes and rattlesnakes are known to reside in the park.

**INSTRUCTIONS**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for An event closed. If a registered dog has been acquired by a new owner it must be entered in The name of its new owner in any event for which entries closed after the date of acquirement, Regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine Partners Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
